<b>Pool</b>	25 metres, 6 lanes, Anti-turbulence ropes, Electronic timing equipment
<b>Sessions</b>	Session 1 : Warm up 09:15 Start 10:15 Session 2 : Warm up 14:00 Start 15:00 Session 3 : Warm up 08:15 Start 09:15 Session 4: Warm up 12:45 Start 13:45 <i>Subject to change if necessary</i>
<b>Events</b>	Individual: 50m/100m/200m all strokes, 800m and 1500m free, 200m IM. 800m and 1500m events will be restricted to 2 heats. Mixed Relays: Medley and Freestyle, must be 2 Male or Open/2 Female with 1 swimmer from each 10/11 years, 12/13 years, 14/15 years and 16+ years (Age up will be permitted).
<b>Age Groups</b>	Age as on last day of meet (10 May 2026) for all events. 9 & under, 10/11 years, 12/13 years, 14/15 years, 16+ years
<b>Consideration Times</b>	No consideration time standards have been set. However if over subscribed there may be scratches.
<b>Start Rule</b>	One start will be implemented throughout the competition. Over the top starts will be used where practicable.
<b>Entries</b>	All swimmers entered must be registered with SASA and have paid their SASA membership fee for the current year. Registration numbers must be included in entry file. Times do not require to be accredited but should be real times achieved at accredited or non-accredited meets or club time trials. An entry time must be submitted for each entry. Orkney ASC reserves the right to restrict the number of heats in any event/s, reserves the right to swim a slower heat for their swimmers and reserves the right to fill any empty lanes with Orkney ASC swimmers. All entries must be on Hy-tek Team Manager entry file. A license has been granted for this competition and accreditation will be applied for to SASA North District</p> <p>2 All swimmers will be required to marshal prior to their event</p> <p>3 Warm ups must be supervised</p> <p>4 Food must not be eaten poolside. No glassware should be taken into the changing rooms or poolside.</p> <p>5 Shoes, t-shirts and shorts must be worn by swimmers in spectator gallery.</p> <p>6 Technical officials and coaches will be provided with tea/coffee and a buffet lunch between sessions 1 and 2, and between sessions 3 and 4</p> <p>7 All participants must adhere to SASA's Acceptable use of mobile phone policy. The following areas are mobile phone free &amp; there is a zero-tolerance policy with regards to use of mobile phones by any individual in these areas</p> <ul style="list-style-type: none"> <li>- Changing rooms</li> <li>- Toilets</li> <li>- Showers</li> </ul>

By entering the Female category, athletes are therefore confirming their birth sex is female and are eligible to compete in the Female category.</p>
